THIS YEAR THE PROGRAM SERVED 137 CHILDREN AND YOUTH RECEIVED 13,121 HOURS OF INSTRUCTION. NATIONS MINISTRY CENTER IS ACCREDITED BY THE DEPARTMENT OF JUSTICE OFFICE OF LEGAL ACCESS PROGRAMS TO PROVIDE LEGAL IMMIGRATION SERVICES. NATIONS MINISTRY CENTER HELPED 250 REFUGEES RECEIVE GREEN CARDS, U.S. CITIZENSHIP, AND TRAVEL DOCUMENTS IN 2017-2018 FISCAL YEAR.
