NATIONS MINISTRY PROVIDED \$653,034 IN MORTGAGE AND UTILITIES SUPPORT IN PARTNERSHIP WITH THE UNITED WAY AND METRO GOVERNMENT AS A PART OF OUR COVID-19 RESPONSE. 353 FAMILIES BENEFITED FROM THIS PROGRAM. WE OPENED 279 IMMIGRATION CASES WITH OUR DEPARTMENT OF JUSTICE-RECOGNIZED IMMIGRATION SERVICES. IN ADDITION, WE CONDUCTED 149 IMMIGRATION CONSULTATIONS. 95 CITIZENSHIP APPLICATIONS WERE FILED. 53 ELDERS WERE SERVED THROUGH CASE MANAGEMENT, AND 296 SERVICE REQUESTS WERE FULFILLED.
